General Overview & Impact

API Changes

In the latest release we have made changes to the API call we make to the Secure API so that we can accommodate devices with different supply types.

Orbit

In this release, we are adding default emergency credit limits to Orbit which will be applied automatically to the hub when it is changed from credit mode to PAYG mode (in Mabdeck).

In this release we have improved the descriptions around security deposit transactions so that they follow the same syntax regardless of the type of transaction.

Credit Control

We have made changes to the flag action functionality of Credit Control. With the new changes, only the most recent/relevant flag action will be displayed and the flag will not be displayed on an account when the account is moved out of credit control. Another

change made was to ensure that credit control is not triggered when a direct debit or Stripe recurring payment is active.
