General Overview & Impact

Multi-Factor Authentication

In this release we have implemented Multi-Factor Authentication. For admin users that have not yet set up MFA, when they next log into Mabdeck they will be redirected to set this up. This will provide better security for users with admin accounts. Users will be directed to download the authenticator app to authenticate their login, and will to remember their login for 14 days, after which MFA will be required again.

Orbit

We have added the ability to have multiple supplies in Orbit, now allowing multiple solutions to be applied to the same Hub. We have also added Default Friendly Disconnect dates and times to ensure that these are applied to all Hubs when they are created in Orbit, removing the need for back-end work when making these changes.
